**AFFIDAVIT**

The Undersigned hereby affirms under penalty of perjury and says:

A. I am Daniel Hirsch of SHF, LLC ("SHF"), a duly formed and validly existing limited liability company which is in good standing under the laws of the State of Iowa.

B. I make this affidavit (the "Affidavit") at the request of MLIC Asset Holdings, LLC ("MLIC") for the purpose of qualifying SHF and the undersigned for the benefit of MLIC to potentially purchase from MLIC certain mortgages, security agreements and promissory notes payable by Agriprocessors, Inc., an Iowa corporation, and the supporting proof of claim No. 166 filed on February 9, 2009 by MLIC in the Agriprocessors, Inc. Chapter 11 bankruptcy case No. 08-02751 with the United States Bankruptcy Court for the Northern District of Iowa, (collectively the "Loan").

C. I have personal knowledge of the facts stated in this Affidavit and such facts are true, accurate and complete in all material respects. Neither I nor SHF have any connection or affiliation, whether direct or indirect, express, implied, contingent or unmaturred, (i) to my knowledge, with any creditors in the Agriprocessors Chapter 11 bankruptcy case other than FB Commercial Finance Inc., (ii) past or present relationship with Nevel Properties Corp or (iii) with A.A. Rubashkin & Sons, Local Pride, LLC, Best Value Distributors, Inc., Best Value Food Products, LLC, Cottonball, LLC, Lagoon Technology LLC, Kosher Community Grocery, Inc., Amereeka Properties, LLC, The Torah Educational Foundation of Northeast Iowa, Gemach Mamash Now Corp, Quantum Farmers Inc. and to my knowledge, members of the Rubashkin family, including any intention to employ or enter into consulting agreements with such parties if I or SHF acquire the Loan.

E. I hereby waive my rights to confidentiality and authorize MLIC to investigate my financial status and business affiliations. This waiver of confidentiality shall automatically expire on June 5, 2009.
